



Conditions for stands at the 24th Sommerlochfestival | CSD Braunschweig 2019

1. **Non-profit groups and stand operators with trade / service who offer no consumption (snacks) and no drinks** can participate only on Saturday, 10.08.2019 from 14.00 to 18.00 o'clock.
2. **Stand operators with trade / service, with consumption (snack) and / or drinks**, can participate on Friday, 09.08.2019 from 18.00 - 22.00 o'clock **and / or** on Saturday, 10.08.2019 from 14.00 - 21.00 o'clock.
3. The VSE e.V. provides the stand operator with a **place at the venue**. The locations of the stands are assigned locally by the VSE e.V.
4. The set-up of the rented **group tents** is carried out by VSE e.V. The stand is set up by the stand operator and in the name and on the guarantee of the stand operator. The locations of the stands are assigned locally by the VSE e.V.
5. The **set-up of all other stands** is done by the stand operators on Friday, 09.08.2019 until 18.00 o'clock or on Saturday, 10.08.2019 until 14.00 o'clock.
6. The **electricity connection to the central distribution points** is made by the stand operator. Extension cords are not provided by the organizer.
7. Each stand operator has to take care of the **stability and traffic-safe construction** of the stand. The stand operator is prohibited by the city of Brunswick to anchor **fastenings** in the ground.
8. Stand operators with consumption / drinks undertake to comply with all regulations on **food hygiene**.
9. The **instructions** given by VSE e.V. and its agents and the security staff must be followed by the stand operator. The stand operator omits actions that run counter to the content or purpose of the event.
10. **Information materials** (flyers) may only be distributed in the immediate vicinity of the stand. For the **distribution of stickers** we charge a fee of 20,00 €. In this way, we finance a check on the inner and outer surfaces of the castle as well as the removal of the stickers from these areas.
11. The stand area and the immediately surrounding area are to be left **swept clean** by the stand operator. Cleaning costs due to contamination of the stand operator are to be paid by the stand operator.



12. The organizer is not liable for **damages by third parties or force majeure**.
13. The **fees charged according to the registration** are payable in any case. Excluded are only cases of force majeure.
14. **Additional agreements** must be made in writing.
15. The **validity of the agreement** shall not be affected by the total or partial ineffectiveness of one or more of its provisions. In such a case, the agreement shall be implemented on the basis of the remaining provisions or general principles of law.
16. The event is freely accessible to visitors of all ages. For this reason, activities that contradict the **protection of minors** should be avoided.
